

Cancellation policy for Kemijoki Experience 16th to 18th of July 2015
Valid from 1st of February 2015 until further notice.

1. Scope

These are the general terms and conditions for the event: Kemijoki experience, 16.7. - 07.18.2015.

The event is organized by Kemijärven Latu, who may modify these Terms at any time by publishing the revised or amended terms and conditions. New contract and payment terms apply after the date of the change for registered participants.

2. Product

The Kemijoki Experience participation fee is 270.00 € / person / rowing place or 190.00 € / person / kayaking place or 220.00 € / person when a group of participating in an event in a own boat. The fee includes the services stated in the program, unless otherwise indicated in the program. Event organizers have all the rights to decide the program publication date, and transform the event program.

Participation fee does not include the second night (17.07. - 18.07.2015) accommodation. Information of accomodations are available for the participant at the event website.

3. Terms of payment

Event Pass includes program services and transport indicated in the program, as well as the meals indicated in the program.

The participation charge need to be payed in a single installment. The participant may request the invoice divided into two if there is more than a month time to the beginning of the event . All payments must be paid prior to the event registration on thursday 16.7.2015.

The participant must have a proof of payment (receipt) of registration with him at the registration on location. The event organizer has the right to decide the participant's participation to the event if any payments are not payed. (eg. Cash payment possible).

Pre-Registration for the event ican be done through the website. This is considered as a final and a binding registration. When registered, the participant will be contacted within a few days after they have sent the form. The participant may, alternatively, register by e-mail. The participant will receive an invoice by electronic means he stated in his register form (e-mail). By good Billing and collection practice, the invoice is dated within 14 days of payment. If the invoice is not paid by the due date, a 1st reminder will be sent within 14 days of the invoice due date. The reminder will be added a 5 € reminder fee. If the invoice is not paid after 1st reminder, the 2nd reminder will be send t within 14 days of the date of 1st reminder. Rmeinder fee (5€) will be added to the second reminder as well. All billing and payments, as well as terms and conditions related questions, suggestions and requests must be made in writing via e-mail: yottomanyonsoutu@gmail.com

4. Cancellation policy

The Kemijoki experience event registration shall be considered binding and an invoice will be send on the basis of the registration. The registration can be canceled free of charge within 14 days of enrollment. Registration form at the event website (www.kemijokiexperience.com) will close 14 days before the event. 14 days prior to the event registration is only possible by e-mail or by phone yottomanyonsoutu@gmail.com if rowing places are still available.

If a participant cancels participation after 14 days, but days to the event is 60 days or more, the entry fee will be refunded at the full price. If a participant cancels participation after 14 days, but day to the event is just 30 days, we will refund 50 % of the participation fee. If a participant cancels participation after 14 days, but days to the event is only 15 days or less, we will refund 25 % of the participation fee. If a participant cancels participation the previous day or the starting date of the event, we will not refund participation fees at all.

If a participant can present a medical certificate that the person can not take part in the Kemijoki experience event, the entry fee can be refunded entirely, regardless of how much time is to the event.

If registered to the event but can not actually attend the event himself, the participant's rights can be transferred to any other person for free. This needs to be, however, immediately informed to the organization of the event:

5. Cancellation of the event

If the event has to be canceled by the organizer before the start of the event, will the participation fees be returned to the registered full price.

If the event has to be canceled or cut short the start date of the event or during the event due to force majeure, such as general cases of force majeure (eg., Strikes, natural disasters, unforeseen interruption in traffic, authority regulations, weather interruptions) no participation fees are returned. The event organizer reserves the right to make changes prior to the event and during the event and referred to above may change the program as possible.

6. Safety and liability

The event organizer is responsible of the safety of the event during the event. The Promoter is not responsible for the participants caused property damage.

Participant is obliged to inform their own health, or other limiting factors to the event organization. The information is confidential.

7. Privacy Policy

The information given in the registration will not be used for any purpose other than the event information. In connection with the information provided will not be given to third parties.

Participant may register for either event website or by e-mail directly to the event organizer.
